ARTICLES OF INCORPORATION

Article One

NAME

The name of this not-for-profit organization is BET HASHEM MIDRASH, INC.—The House of The Name Academy Incorporated. A *midrash* is an academy, a House of Study and Public Service. The name, BET HASHEM, is a linguistic language phrase to convey the Body/Residences in which all peoples abide.

Article Two

DURATION

The period of its duration is perpetual.

Article Three

PURPOSE

To engage in and do, every activity and to exercise every right and power authorized by the Indiana Not-For-Profit Corporation Act of 1971. Its purpose is to transact the business and all other business not forbidden by law to fund projects of the Midrash. Bet HaShem Midrash, Inc. (BHM) is organized for charitable and educational purposes. The academy interfaces with other institutions of education, including community schools, both public and private institutions of learning. Educational materials are provided free. The academy provides free resources of publications and encourages comparative linguistic research to establish peace amongst all peoples. Linguistics, through analysis of the origins of Words, affirms natural commonalities between civilizations and cultural groups. BHM is a non-profit of 501(c)3 org. stature reviewed by Dulin, Ward & DeWald, Inc. The Academy is an institution of linguistics for universal peace obtained through understanding common literary heritages of human-kind.

Article Four

ADDRESS

The address of its registered office is 13539 Old 24 E, New Haven IN 46774-9006.

The name of its registered agent, Shmuel Wahli, at such address is 13539 Old 24 E, New Haven IN 46774-9006.

Article Five

MEMBERSHIP

The number of members may include the board of directors to be comprised of a minimum of three persons. Membership is open to any person with linguistic objectives for universal peace.

Article Six
TRUSTEE

The Academy receives donations of time and talent for publications and public access to free resources. BHM may receive property by devise or bequest subject to the laws relating to the transfer of property by will. The Organization may be appointed as a Trustee under any trust incidental to the principal objects of the organization and receive, hold, administer and expend funds and property subject to such trust. The Organization may enter into, make, perform and carry out contracts of every kind for any lawful purpose without limit as to amount and to draw, make, accept, endorse, discount, issue and execute promissory notes, warrants, and other negotiable or transferable interest. The Organization may take, purchase, or otherwise acquire; to own, hold, occupy, use and enjoy; manage, improve, develop and work; to grant, sell, rent, exchange, let, demise and otherwise dispose of real estate, buildings and improvements and every right, interest and estate therein without limit as to the amount thereof and wheresoever the same be situated; to erect, construct, alter and renovate buildings; to assume any and every kind of contract, agreement and obligation by or with any person, firm, corporation or association, or any Federal, State, or other Government for the use or any buildings, improvements or structures of any kind, including equipment and software that will benefit and carry forth purposes of the Academy. Business is conducted by the President who serves as the registered agent. The Organization may purchase, own, hold, lease, assign, rent, transfer, exchange or deal with personal property of every kind and description without limit as to the amount and wheresoever the same may be situated.

Article Seven
LIABILITIES

Every director and officer shall be indemnified against all liabilities, civil and criminal, incurred in relation to his duties, including all reasonable expenses of defense, except to the extent that one shall have been finally adjudged to be liable for negligence or misconduct in the matter out of which the liability arises.
