

## COMMUNITY

### Basis

The basis of community is founded on the arrangement of our Names within the Collective Body of Unified Thought. Every community is first set by a Judge, whereby the space is determined for a specific purpose to fulfill the intent of occupation. Wisdom speaks through Dan; for all matters are determined based on the mutuality of qavilah. The worlds are founded on the Words of a Judge, and to the Judge the world and all communities within it shall give answer as to fulfilling their obligation amidst all inhabitants. The worlds are not made for a single/individual; every person is made for another and for the world/age/state that has been determined for the Universal Mind.

### Continuity

The Words of Community are spoken and implemented unto Liberty and Life. Though a thought or form is judged unto death, the motive of the judgment is unto life and liberty, whereby all decisions of the Community are unto Life alone. If another, or a thought, or a practice, or a form, hinders another within the Community, it shall come to cessation by the decisions of the Judge, so that which is appointed unto Life may live. The Judge is before all ages and aúwtim/epochs, whereby at the end of an age the Judge shall appear to appoint all who have served in the Name of the Judge to enter into their subsequent domains. The Community is first, the individual is secondary.

### Finances

#### Contributing Members:

Members may contribute any form of asset to the community providing it is acceptable to the Governing Board of the Community. The Governing Board is comprised of all members, each having a Voice and a vote in all matters. Assets are acceptable after a member has lived in the community for thirty days, except for the initial start-up charter members. Capital monies given to the community are to be invested into projects and in other forms of generating revenue. The community will honor a member's investment. Should a contributing member sever ties with the community, the initial funds may be returned to the member, but there is no guarantee the funds will be available upon departure; however, every attempt to return an initial investment will be made once the funds are liquidated from an investment. Should a contributing member pass-on, funds, either entirely or in-part, may be distributed to their heirs or remain permanently in the account of the community according to the will of the member. Funds that are contributed are both secured and nonsecured. Secured funds are those for investments; nonsecured funds are for consumable operations. Funds from new members may be transferred to former departed members investment upon approval of the community. Funds in investment accounts may be transferred to former departed members upon availability. Every attempt will be made to reimburse the member with like assets, but the community will not be held liable for the change in the market or for liquidation of funds that have been consumed for daily operations. Funds received will be put to use for the building and development of the community. Each member agrees with intent and purpose, with a written statement of compliance for an investment strategy.

#### Non-contributing Members:

Members may be accepted into the community upon merit without asset contributions. Should a non-contributing member sever ties with the community, no assets are transferred to the member upon departing. Should visitors stay at the community, the suggested diem per week is 179.00 for one person for occupancy. Visitors are to provide assistance with all community processes including staples and supplies.

#### Assignments:

All community members have assignments that pertain to accomplishing the goals of the community. If the community's goal is publications, then all members are in agreement of the project and committed unto its fulfillment. All supportive duties will be performed for the sake of the community goals.

#### Mutual Care:

Community Members may be assigned to another, whereby they serve as pairs. Some pairs may be for a phase of the project, or for a lifetime. Devotion to another should be expressed in terms of qavilah, as suitable upon agreement of the parties comprising a pair. Assignments and teamwork are to be achieved between all parties by agreement and mutual consent.
